PATCH: WILL BE FURNISHED BY CONTRACTOR.

PATCH SIZE WILL BE 4" WIDE ON TOP, 2.5" ON THE BOTTOM, 5" HEIGHT

BACKGROUND MATERIAL TO BE DARK GREEN. ALL FABRIC MUST BE CERTIFIED WASHABLE BY THE INTERNATIONAL FABRICARE INSTITUTE.

COLOR OF OVERLOCKED MERROW EDGE: GOLD. OVERLOCKED MERROW EDGE; MUST BE APPLIED TO EMBLEM AFTER THE LOOM OPERATION. A RUNNING STITCH SHALL SUPPORT BY THE ZIG-ZAG STITCH WHICH SHALL BE APPLIED UNDER THE OVERLOCKED MERROW EDGE TO PREVENT THE MERROW EDGE FROM PULLING AWAY FROM BASE FABRIC. A STRAIGHT LINE RUNNING STITCH WILL NOT SERVE THE PURPOSE. THE OVERLOCKED MERROW EDGE SHALL CONSIST OF SEVEN SEPARATE THREADS. FIVE 150/2 DENIER RAYON THREADS FOR THE TOP PORTION OF THE EDGE AND TWO 20/2 DENIER COTTON THREADS FOR UNDERNEATH OR BACK SIDE OF EMBLEM. EDGE DENSITY MUST BE AT LEAST TWENTY-TWO THREADS PER INCH. THE OVERRUN SHALL BE A MINIMUM OF 3/8" TO PREVENT REVELING.

A THERMAL PLASTIC (HEAT SEALABLE WITH MELT BOND OF 240 DEGREE TO 255 DEGREES FAHRENHEIT) IS TO BE BONDED TO THE BACK OF THE EMBLEM IN SUCH A MANNER AS TO BOND THE FABRIC, BACKRAM, BOBBIN THREADS TOGETHER WITHOUT CRUSHING THE EMBLEM.

SECURITY STATE OF VERMONT AND DIVISION LETTERS SHALL ALL BE CAPITAL LETTERS AND CENTERED.

SIZE OF LETTER WERE SHOWN ON RFP PHOTOCOPY.

STATE SEAL TO BE IN CENTER OF THE PATCH.

WORKMANSHIP: THERE MUST BE NO DISTORTION OF THE EXTERIOR SHAPE OF THE EMBLEM. THE FINISHED EMBLEM SHALL SHOW A CLEAR CUT EXECUTION AND SHALL BE CLEAN, NEATLY MADE AND WILL FULL TENSION ON ALL THREADS. IT MUST BE CAPABLE OF LYING COMPLETELY FLAT ON A FLAT SURFACE. THREADS CANNOT BUCKLE OR SHOW UNDERLAY WHEN THE EMBLEM IS BENT.

INSPECTION: THE MANUFACTURER MUST INSPECT 100% OF THE EMBLEMS AND REJECT ALL EMBLEMS THAT DO NOT MEET THE APPROVED STANDARD.
