CONTRACT PERIOD: AUGUST 20, 2013 - MARCH 31, 2015 WITH OPTION TO RENEW FOR TWO (2) TWO (2) YEAR PERIODS.

THIS STATE OF VERMONT CONTRACT #23066 (THIS "CONTRACT") IS WRITTEN UNDER THE AUTHORITY GIVEN TO THE COMMISSIONER OF BUILDINGS AND GENERAL SERVICES IN 29 VSA, PARAGRAPH 903A TO PARTICIPATE IN COOPERATIVE PURCHASING AGREEMENTS WITH OTHER STATES.
